The TASER Training Academy is pleased to announce that we are organizing a TASER Master Instructor course to contribute to the self-protection of employees of authorities with security tasks and military personnel.

Participation in this course is only open to active employees of authorities with security tasks, such as the police, customs, justice and security services or active military personnel. (Proof of service ID or letter of confirmation required) Participation in this course by companies or associations etc is not possible. Retired police officers or military, previously selected by Axon, will be allowed to participate.

The course language will be Italian and English, depending on the number of participants we can also offer the course in French, Spanish or German speaking groups.

Participants in the course must attend all five teaching days on a compulsory basis (Mon-Fri). Registration takes place on Sunday, 30 June, in the evening. The training courses take place daily from 08.00h - 17.00h. However, this may change depending on the availability of the training facilities. The training ends on Friday 05 July at 16:30h. Participants who leave before the end of the course will NOT have completed the requirements to receive a TASER Master Instructor certificate!

On the Sunday evening, all participants will give a short presentation (max. 5 min.) about the background experience of TASER application and the operational tactical approach in their organization in order to initiate an exchange of practical experiences among the participants.

This course will include information and application on all available TASER weapons (TASER 10, TASER 7, X2 & X26P) and demonstration of the new VR kit, data management, forensics and maintenance, body cams, Evidence.com/Commander software for evidence management and provide a general overview of Axon's product portfolio.

The participation fee for the Master Instructor course is:

1.250,00 Euro (plus VAT) per participant

and includes all training materials, the use of the TASER and the required cartridges, a possible voluntary self-exposition, as well as lunch and a coffee break. Furthermore, a networking evening event is planned. Hotel accommodation that may be required, as well as transport between the hotel and the training ground, are not included in the price and must be organized by the participants themselves. Invoices are sent to the sending authority or the individual. Please let us know the tax ID of your department or your fiscal code.

First-time participants of the Master Instructor course must meet the following requirements:

- ▶ Active employee of a public authority with security tasks, such as police, customs, judiciary, regulatory authority or active in military service.
- ▶ 5 years of professional experience, ideally in operational training.
- ▶ If the authority already uses TASER
- ▶ Ideally 2 years TASER instructor experience.

Many authorities are currently starting to use Axon / TASER products. In this case, participation is possible with appropriate professional experience as a deployment trainer or weapons specialist. Appropriate training in self-defense, operational tactics or firearms use is important.

Conditions for ALL participants:

- ▶ Participation in all physical exercises and activities during the course (full duty clearance required).
- ▶ Please do not apply if you are unable to participate in a physically demanding training environment or are limited duty/not cleared for full duty by your department.

Documents required to apply to participate:

- ▶ Fully completed and signed participation application and disclaimer.
- ▶ Informal letter of confirmation from the department of active-duty status and support to attend this course.

First-time participants please submit the following additional documents:

- ▶ Current brief curriculum vitae (with emphasis on training experience).
- ▶ If applicable: description of successfully conducted TASER user courses (number of courses and number of participants)

These documents will be provided to each applicant. If you already have an injury or condition that would be aggravated by physical exertion, muscle contraction or exercise, please describe the injury or condition in detail below and inform the instructor before engaging in any physical activity or exposing yourself to the TASER. If practical, your instructor will perform exposure to a TASER on a body part that is outside the range of your pre-existing injury or condition. You will be required to sign the "Master Instructor Course: Warnings, Risks and Disclaimers" document prior to commencing the training. No one will be admitted to the course without having fully read, understood, agreed to and signed this form.
